Old Business: Introduction of members and guests. Mike Galliard from MidAmerican Energy discussed the Inspector Database that is near complete. There was discussion on ICC voting online and Final Action Hearings.

New Business: Bob Buck discussed requests for endorsements for ICC Section C Board of Directors he has received- no members were aware of the candidates and wanted to endorse any party at this time. Julie Ackerman discussed the Creative Homes tour in September and the books of these homes that could be purchased at Hyvee. Julie Ackerman and Bob Buck discussed bracing questions and training for homebuilders on diagonal bracing and truss packets. Frank Ehrecke discussed the mis-information and lack of training on the issue. Julie Ackerman went to Bettendorf City Council meeting and reported that Bettendorf was keeping 2009 codes for sprinklers requirements. Frank Ehrecke discussed differences of chapter 5 IRC in 2009 vs. 2012 in floor requirements and sprinklers. Bob Buck and Tom Ayers discussed local code adoption and requirements. Rock Island City does not require residential sprinklers currently and has concerns about premature floor collapsing only (Tom Ayers). Bob Neale: speculated on sprinkler legislation to come; IPDH took the IAMO plumbing (Green) code for adoption; Iowa plumbing board and codes wants to advocate for ICC consistent plumbing codes. Greg Thorpe discussed swing away gates for swimming pools on stairs.
