Old Business: Introduction of members and guests. Ray Nees discussed Cedar Rapids, IA's adoption of the 2012 (except IBC) codes and the IABO advisory committee is looking to adopt similar codes as ILLOWA. Tom Ayers discussed the local jurisdictions receiving their ISO letters the necessary adoption of 2012 codes to save each jurisdiction's ratings. Tom Ayers also discussed his upcoming trip to Springfield with ICCA to discuss the adoption of the 2012 NFPA101 and the concerns surrounding it. He also encouraged all jurisdictions to write letter and discuss this issue with the state reps. Bob Buck discussed the Iowa alternatives to sprinkler requirements for adoption.

New Business: Bob Buck shared handouts on Smart Vents for flood plains and Foundation Support Works from Midwest Basement Solutions for possible discussion at a later date. Tom Ayers discussed regulating pressure in houses for blower door testing and the 2009 and 2012 IBC/ IRC requirements for CFM's. Tom Ayers and Bob Buck expressed concern about the "degree of tightness" and have asked for an advisory committee to reconvene at the State level. Ray Nees informed the group of an upcoming November class for help in getting ICC certifications (emailed info to the group). Bob Buck announced an ICC contest for jurisdictions to get certified. City of Rock Island received an honorable mention on the website for being fully certified. Julie Awkerman reminded the group of the upcoming Parade of Homes event in September.
