- Denny Newell thanked the ILLOWA volunteers for helping with the Lowes Contactor Luncheons
- Greg Marty stated that there was 2 sprinkler trailers in the area for demos on nicer dayscontact him about it. He was also keeping an eye out for future training opportunities (fire related) for the group.
- Homebuilders- Homeshow is Feb 5-7, 2016 and volunteers are needed for the ILLOWA Booth.
- Ray Nees discussed fire separation and protection for 2 hour requirements on assemblies and what areas need it.
- Bob Buck and Jeff Thomas discussed illegal electrical hook ups to masts and the possible repercussions of the illegal work.

- Bob Buck informed the group that American Dream Homes was solicitating in Leclaire. Roofers
  were placing old/ used shingles in yard and new ones on porches after a storm and then forced
  homeowners to put on roofs because it looked like they already started working.
- Tim Schmitz/ ICC Rep discussed a new 40% requirement starting in January 2016 for CEUS and increasing in July 2016. More information to come.
- Tim Schmitz also gave updates on: Rockford passed sprinkler ordinance that excludes only single family homes; IL JCAR pushed back 45 days on IECC adoption and IA adoption pushed back also and will have further information in December; and ICCA having issues with roofers and R-values on older structures.
